# EX15.07.23.7. Planning Guidelines and Noise Policy

Verbal update on draft document.

Currently awaiting input from LGA, then to be circulated to EPA and others for final comment.

Sonus – to undertake some sound testing for modelling purposes. Difficulties due to access to venue (track redevelopment) and weather.

## EX15.07.23.8. Request for donation of Rider Levies – Ariel

Correspondence attached.

Normal protocol has been to provide donation of levies for bone fide charities, or to individuals that are experience hardship through some injury of major trauma/event.

The Club has nominated a swimming club, on the basis of its water safety program. Whilst a great initiative, and valuable for the community it does not have a direct correlation with motorcycling.

The club has been a regular contributor to Motorcycling SA charities through its events, in addition to the club based community support it provides to areas where they ride.

The event seeking a donation from is a non-competitive trail ride, with approximately 100+ riders.

Board supports clubs engagement in local communities. Link between Ariel club and the swimming club

#### **Decision:** Declined

#### **GENERAL MANAGER to advise, based on:**

- Precedent has been to donate to bone fide charities, or individuals suffering from trauma/significant hardship.
- Supports their approach to engage with the community
- Motorcycling SA already is supporting Beyond Blue this year.

### EX15.07.23.9. Riverland JMCC

Riverland JMCC has been tardy in providing competitive and non-competitive reports.

Additionally and more importantly it appears to have allowed major breaches of our rules, specifically relating to 50cc juniors.

The most recent example relates to the alleged enabling of a 5 yo (nearly 6) competing in the Div 2 50cc class 7-u9.

This results in:

- Non-competitive licence holder competing
- Rider under 7 competing

It is requested that the Board appoint an investigator to review the meeting, and determine if any charges should be laid.

In the ongoing issue with getting to speak to Doug Spanos (President) and the serious nature of this matter it is proposed to send that attached letter.

Recommendation: That the above action be approved.

Decision: That Steven Matthews, Operations Officer be appointed as investigator, GENERAL MANAGER to send letter to Riverland advising such.
