Discussion to clarify follow up e-mails to Board on process for MA Director Election. Clarification on vote by MSA, given withdrawal of candidate.

Meeting Summary

 - Constitutional changes

- Discussion on issues:
 - Need to ensure inspectors are critical from a risk perspective

- Recognise that every requirement/non-compliance takes work, effort and costs for clubs to remedy
- How are track builders and maintenance crews provided the skills to develop and maintain facilities? Work being done by GM to provide some guidance of best practice.
- Discussion on route markers (people who design course) for Enduro and Reliability Trials.

Trail Ride Standards

- MSA has been contacted by consultant who is undertaking a review of the standards, on behalf of the SA Government.
- Standards provide "best practice' guidance on how to run trial ride, and legal obligations on organisers
- We are putting together a broad representative group, including from outside our affiliation, to input and assist the process.
- Whilst it has little relevance to our delivery, it is an opportunity to input, and potentially gain some ideas for improvement.

EX14.06.16.8. Request for affiliation – Promoter (Recreation) – Tintinara Action Club

Tintinara Action Club is an incorporated body that has traditionally run the Annual Sand and Swamp Trail Ride around Tintinara. It has generally done this under the auspices of and permits through Meningie MCC.

With the uncertainty of the status of the Meningie MCC, the group would like to have control over its own event. It is not looking to be an affiliated club as its objectives are not related to motorcycle activity per se, rather the group delivers the trail ride as a key fundraiser for the area.

The same officials would be utilised.

In accordance with the MSA constitution, Section 11 & 12 the MSA Board can determine whether to approve the application, and as the party is seeking to be recognised as a promoter, the process for club consultation is not required.

Promoter affiliation does not provide rights to vote at General Meetings, nor does it afford the entity Directors and Officer's Liability Insurance.

Recommendation: Approval of affiliation of Tintinara Action Club as a Recreational

Promoter.

Decision: Approved

Need to establish clear process for permitting and registering Ride Parks

Proposed parks that would like to be MSA endorsed in:

- South East
- Mid Murray
- Flinders Ranges

Discussion on need to make our offering relevant, affordable, and yet protect liability through insurance.

Proposed concept document outlined.

Focus on management practices and Venue Layout and form (inspected tracks, but not licenced).

Track separation, control of riders

Board support the concept.

- Further work to consider of the likely return against the increased liability
- Look to grow sport, and increase exposure

Decision: General Manager to further develop proposition.

EX14.06.16.11. Reliability Trial – Property risk

Recent illegal riding on private property has resulted in the loss of two properties used for the 24hr.

Riders affected stock, cut fences. – most recent instance was on 25 May 2014.

It is unknown at this time if any of the riders are licenced or linked to clubs.

It has been asked what action MSA may consider if it is proven that the rider was guilty of riding unauthorised, and is a licence holder.

Any process must respect the provisions of natural justice, but I would like to consider the proposition of establishing a mandatory sentence for such an offence.

Board discussed the severity of such matters, and provided full support for disciplinary action to be taken against any identified MSA licence holder.

Discussion on position of mandatory sentence, however Board determined to consider each instance on its merits, to enable full consideration of all factors.

GM proposed a release to clubs and local media on Board position, which includes:

- · Severity of impact illegal riding has
- Fines (as per GCR's)
- Exclusion
- Suspension of up to 2 years
- Support for land owner to enable them to pursue civil claim against offender.

Decision: Board fully support GM's proposal. GM to develop and distribute.
