Business Arising From Minutes:

MX Minutes – Kerry Marsh – advised that the National Sidecar MX Champion will be issued the Duke of Edinburgh Trophy.

Reliability Trials – Kerry Marsh - Discussion on Reliability Trials and clarification on its position as a bone-fide discipline within MSA/MA, and the availability of the Supplementary Rule Book. Question raised due to enquiry from a member who could not find link through MA.

Building Façade – no action as yet. Discussion on approach by Motorcycling Queensland, and Motorcycling New South Wales. Reaffirmation that MSA is primarily a club resource, albeit that it has direct interaction with riders and the public through the licencing process. Discussion on image to public and clubs.

ACUSA Park – Kerry Marsh – Atujara hosted its first ride day. Discussion to continue with the Committee on continued development of the facility. 20Kva Gen set on site – on loan from Brenton Matters. Equipment from Tailem Bend proving beneficial. Question on donation of material. Delays to ensure redevelopment of dirt track is achieved as a priority, prior to material being used for MX tracks. Plans developing with Bill Mitchell and others on the design, including scope for speedway style training track.

EX14.05.12.6. Confidential - Incident at Event

Report from Operations Officer into the incident tabled.

Discussion on many failings in the situation.

Discussion on what action to take, with dilemma on proceeding to prosecute, given greyness of many aspects, and likely inability to successfully achieve guilty finding, and impose a penalty.

EX14.05.12.7. MX Sports Management

Shannon has advised that she will be standing down from the end of the 2014 State Title Season (September)

Discussion is needed on how we can structure MX to ensure a spread of load for anyone taking on the Sports Manager Role.

Concept could be Board appoint an Executive Group.

Key Responsibilities are:

- State Title Series coordination including sponsorship etc
- Grading
- Rider Numbers
- Development/Growth of the Sport
- Rider Liaison

GM to have further discussion with potential persons, and consider structure to ensure achieve best result.

EX14.05.12.8. Meningie MX

MSA has been contacted with regard to the plight of Meningie MCC, with a lack of members and an inability to form a committee.

It has advised that it will likely go into recess, hoping that at some stage in the future locals will be in a position to re-activate the club.

It currently leases its track from Coorong Council

Meningie MCC has requested that MSA consider whether it would take on the lease for the site. Annual Lease fee is understood to be \$250 pa.

In 2013 the track was used by both Quad clubs for enduro MX format meetings.

Should it not be required or no new affiliated tenant found it is possible that Council could demolish the track and use the land for other purposes.

Decision: GM to pursue potential protection of the Meningie MX Track, through

lease control, to ensure multi club use, and protect right of return for

Meningie MCC.

EX14.05.12.9. Request for Donation of Rider Levies

Keyneton MCC is running its Reliability Trial as a fund raiser for bushfire affected properties in the region.

Letter attached.

Keyneton has requested that rider levies be donated to the cause.

Keyneton has advised that its Executive Committee will be responsible for the disbursement of all monies from the Fund, with Ben Zander appointed as property owner liaison.

Decision: MSA Board Approves the donation of rider levies to the Fire Recovery Fund

managed by Keyneton. Any donation to be recognised as from MSA.

OTHER BUSINESS

EX14.05.12.10. Exclusion zones around events

In 2014, based on feedback from MX clubs, the office imposed some protection zones around State Title events and 'Blue Ribbon'. The priority is to avoid conflict with competition events, with the following applied:

- No competition event to be permitted in competition with the same discipline State
 Title
- No Competition Event to be run in conflict with club Blue Ribbon event.

Issue: Can clubs run non-competition days against state title events?

Discussion: Due to significant number of recreational riders participating in ride days, it is considered more important to facilitate opportunities for people to ride. If a club decides that it has the resources to run an event, and riders want to ride, then it should be allowed.

It is suggested that clubs within 100km of a State Title Event or Blue Ribbon Event be made aware of the adjacent event, and encouraged not to run against the event, however they will not be prevented from running if the decide to. In essence it will be reliant upon club discretion as to what they will do.

Decision: No permitted competition event will be allowed in SA if the same

discipline National Event is being held.

No permitted competition event will be allowed in SA if the same

discipline State Title Event is being held.

Clubs have the opportunity to run non-competition activities at any time, subject to approval by MSA, with encouragement to consider any events

being held within close proximity.

EX14.05.12.11. Photographer Policy

Proposed policy and guidelines provided for consideration.

Aim is to provide guidance and establish some controls around on track photographers.

Decision: Approved
