3. **ENTRIES:**
 - 3.1. Entries open forthwith and close at completion of sign on.
 - 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the South Coast MX Club, if such retention is approved by Motorcycling SA Inc.
 - 3.3. Only entries received on the official entry form that is accompanied by the correct fee will be accepted.

8 AWARDS AND PRIZEMONEY:

Awards will be presented for the Top 3 at the completion of racing. All non-competition participants will receive an award.

9. ENTRIES TO CONSTITUTE A CLASS:

- 9.1. To constitute a class, the number of contestants entered and competing in each class shall be five (5) per class.
- 9.2. Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and / or prizemoney, will be at the discretion of the South Coast MX Club, subject to Motorcycling SA Inc. approval.

10. RACE FORMAT:

To be determined on the day subject to entries. Race order will be advised after sign on.

11. MACHINES AND RIDERS:

- 11.1 All machines entered must comply with the current GCRs for motocross competition.
- 11.2 Multiple entry of the one machine in the same class of competition is not permitted.
- 11.3 If you need to change bikes throughout the day inform Race Secretary in the Lapscore Box who will complete a "Change of Machine" form.

12. GRID POSITIONS:

Start Gate positions by random peg draw for first Round then by finishing order for each Round.

13. RIDERS' BRIEFING:

A riders' briefing will be held prior to the commencement of racing, which ALL competitors MUST attend. All riders are required to commence and complete at least one full lap of practice – no practice, no ride. The Clerk of Course has discretion to waive this requirement for riders unable to complete a lap once commenced, due to mechanical or accident.

14 DRUG AND OR ALCOHOL TESTING:

- 14.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Anti-Doping Authority and the Motorcycling SA Drug and Alcohol Policy.
- 14.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- 14.3 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 6am with the completion of the meeting for the participant being when the participant has vacated the venue.

15. CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

17. CIRCUIT DESCRIPTION:

Track consists of man-made jumps, drop-offs, banked curves, berms, straights, whoops and tabletops, approximately 1.65 kms.

18. STARTS:

40 Gate - Drop Back with 15sec & 5sec Board

19. RACING:

Practice – number of laps will be advised at Riders Brief.
3 Rounds of racing for all riders.
, Seniors 5 laps, Juniors 4 laps, Demos 10 minutes.

20. NOISE: Changes implemented from 2013

- 20.1 Noise emission levels have been changed: with the 2m max method, the limit is 112 with a 4dB/A allowance
- 20.2 Competitors may be required to undergo a static noise test during the event.
- 20.3 No person may compete in any event on a machine whose emissions exceed the limits as noted in GCR
- 20.4.1 If a machine fails it can be presented for re-testing several times.

21.5.1 SPECIAL NOTES AND WARNINGS:

- 21.1 It is recommended riders become familiar with this race Supp Regs and 2017 Manual of Motorcycle Sport.
- 21.2 Dogs are not allowed ON THE PROPERTY during racing only an Accredited Guide Dog.
- 21.3 Alcohol and Smoking is NOT PERMITTED in the pit area.
- 21.4 Facilities: Toilet and showering facilities available onsite. Canteen facilities available.
- 21.5 Dinner available on Saturday night 6-7pm.
- 21.6 Free camping Saturday night.
- 21.7 STRICTLY NO NOISE AFTER 10PM SATURDAY NIGHT.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

2. In this declaration:

- a) "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- c) "MA" means Motorcycling Australia Limited;
- d) "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
- e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
- f) "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

3. I ACKNOWLEDGE that:

- a) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
 - i) I may be injured, physically or mentally, and may be killed;
 - ii) my machinery or equipment may be damaged, lost or destroyed;
 - iii) competitors may ride dangerously or with a lack of skill;
 - iv) track or event conditions may be hazardous and may vary without warning or predictability;
 - v) organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
 - vi) any policy of insurance of or in respect of my life or physical or mental health may be voided;
 - vii) there may be no or inadequate facilities for treatment or transport of me if I am injured;
 - viii) I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- b) the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- d) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

4. WARNING UNDER THE Australian Consumer and Fair Trading Act 2012 (Vic)

Under the provisions of the Australian Consumer and Fair Trading Act 2012 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:
- rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22N of the Australian Consumer and Fair Trading Act 2012 (Vic) the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 (Vic) if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

6. The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.
7. A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

MEDICAL

8. I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.
9. I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

PRIVACY

10. MA, my SCB use and disclose personal information for the purposes of conducting and administering Motorcycling Activities and other related activities, including for identifying participants, recording results and providing member services or promotional material. MA collects, uses and discloses personal information in accordance with its privacy policy. MA may share your information with third parties as required by law, and including but not limited to disclosing your personal information for the purpose of administering Motorcycling Activities. The MA privacy policy contains information about how to access and correct personal information held by MA or how to make a complaint. Applications or services may be rejected if requested information is not provided. In certain circumstances, your information may be disclosed overseas, for example, to FIM. Contact information and a copy of MA's privacy policy is available on our website at www.ma.org.au/.



PERSONAL HEALTH INFORMATION

11. I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

a) I ACKNOWLEDGE that:

- i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
- ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organisers and facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and
- iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).

b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:

- i) may collect and store any of my Information, including obtain my Information from third parties including my Carers;

12. Any participant infringing MA's policy or refusing a drug test may be disqualified or otherwise dealt with in accordance with the terms of the anti-doping policy.
