1. **ANNOUNCEMENT:**

The Quad Riders Association of South Australia Inc hereafter called the PROMOTER will conduct Mannum 2 Day Enduro on the 4th and 5th of August 2018 for ATV Senior Ironman and Teams. The track to be held at the Haby's property on Herbig Road, Mannum, 5238, SA.

2. **JURISDICTION:**

- 2.1. The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Number C18085 and is open to holders of current Motorcycling Australia Senior & Junior National Licences, Mini Licences (Demo only) and one event competition Licences.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, and any final instructions approved by Motorcycling SA Inc.
BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. **ENTRIES:**

- 3.1. Entries open forthwith and close last mail on the Thursday prior to the event.
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by Quadriders Association of South Australia Inc. if such retention is approved by Motorcycling SA Inc.
- 3.3. Only entries received on the official entry form that is accompanied by the correct fee will be accepted.
- 3.4. **NOTE:- LATE ENTRIES WILL INCURE A LATE ENTRY FEE OF \$15, AND THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING ARE AT THE DISCRETION OF QUADRIDERS ASSOCIATION OF SOUTH AUSTRALIA INC.**

4. **INSURANCE:**

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- 4.3. **IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.**

5. **MEDICAL SERVICES:**

St John's Medical Service will be in attendance for the full duration of Racing.

6 **ENTRY FEE:**

- 6.1. Senior Ironman \$100, Senior Teams \$80 per rider.

8 **CLASSES OF COMPETITION**

Enduro: Senior ATV Ironman Up to 930cc, Senior ATV Teams Up to 930cc.

9 **AWARDS AND PRIZEMONEY:**

A presentation announcement will be made for 1st, 2nd, and 3rd place in each competition class.

All accumulated points throughout the Enduro events will be tallied at the end of the Series and trophies will be awarded to 1st, 2nd and 3rd for all competition classes. Series points will only be allocated to full financial Quadriders SA Club Members.

10 **ENTRIES TO CONSTITUTE A CLASS:**

- 10.1. To constitute a class, the number of contestants entered and competing in each class shall be three (3).
Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and / or prizemoney, will be at the discretion of the Quadriders Association of South Australia Inc, subject to Motorcycling SA Inc. approval. Minimum of 10 entrants and a maximum of 30 entrants for the event.
NB: Minimum 3 entries per class required to distribute points for the Enduro Series.

11 **RACE FORMAT:**

A prologue will be run for this event. The prologue will be run 2 at a time. Your prologue time will determine starting order. Your prologue time will be added the total race time for the event. If running teams your times will be averaged to determine your teams time. For each heat, competitors will start 15 to 60 seconds apart, to be confirmed at Riders Briefing pending conditions on the day. Racing cross country on sand, scrub, rocks, and hard packed terrain environment with both natural and formed obstacles. Competitors MUST follow marked course. Saturday and Sunday will both be a 2 hour timed course. The race ends when each rider crosses the finish line after the nominated race duration. Outright and Class finishing positions will be determined by total of 35 point system scores with any necessary decider determined by number of full completed laps and fastest total time taken.
Any cutting of course will result in rider disqualification, this track is run around the owners farming crops and NO running on any crops will be tolerated. Officials will be moving around the course wearing high visibility vests identified to entrants during riders briefing.

12 **MACHINES AND RIDERS:**

- 12.1. All machines entered must comply with the current GCRs for ATV Enduro competition.
- 12.2. Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3. Changes of machine is permitted providing the substitute machine has passed scrutineering.
- 12.4. To participate in the event, it is the rider's responsibility to present all their machines at the designated scrutineering point and pass scrutineering before Competition.
- 12.5. Riders must display number plates on their machine which comply with the 2018 GCR's
- 12.6. To compete, all riders must have clearly visible numbers on his or her back that comply with the 2018 GCR's. NO BACK NUMBERS may mean NO POINTS.

13 **GRID POSITIONS:**

Enduro: Start order will be determined by prologue times.

14 **RIDERS' BRIEFING:**

Riders Brief for Enduro will be 15 minutes before sighting lap.

Riders will be required to sign on to say they have attended riders briefing. Details will be included in the final instructions.

14.1 PRACTICE: A lead non-compulsory sighting lap of the full race track will be offered prior to race start, this is non-competitive, no overtaking and not at race pace. ALL competitors are recommended to utilise this opportunity to view the track.

15 **DRUG AND OR ALCOHOL TESTING:**

- 15.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency and the Motorcycling SA Drug and Alcohol Policy.
- 15.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- 15.3 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be at the start of sign-in with the completion of the meeting for the participant being when the participant has vacated the venue.

16 CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

18 CIRCUIT DESCRIPTION:

Enduro: The race courses consist of varying natural terrain areas with established tracks through scrub vegetation, sand, hills and natural terrain.

19 STARTS:

ENDURO: Individual flagged starts at 15-60 sec intervals (determined by officials on the day).

20 NOISE:

21.1 Noise emissions levels have been changed: with the 2m max method, the limit is 112 with a 4dB(a) allowance

21.2 Competitors may be required to undergo a static noise test during the event.

21.3 No person may complete in any event on a machine whose emissions exceed the limits as noted in GCRs.

21.4 If a machine fails it can be presented for re-testing several times.

21 GST:

The Goods and Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prize money over \$75.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.

22 SPECIAL NOTES AND WARNINGS:

23.1 **NO tear offs are allowed in all events (including Pro-log).**

23.2 **ALL REFUELLING MUST BE DONE WITH ENGINE OFF AND RIDERS OFF THE BIKE AND IN THE DESIGNATED "REFUELING ZONE". THIS WILL BE CLEARLY BUNTED WITH FIRE EXTINGUISHER'S PRESENT AT ALL TIME. NO REFUELING IS TO BE DONE IN THE CAMP AREA OR PIT AREA AT ANY TIME FOR THE DURATION OF THE EVENT.**

Environmental mats 500mm long and at least 400mm wide must be placed under all motorcycles whilst refuelling or changing oils. Carpet or any material not made for the absorption of petroleum products is not allowed to be used.

23.3 Helmets must be worn at all times whilst on any motorcycle. This includes unloading, loading and scrutineering etc.

23.4 **Bikes are highly recommended to run a rear operational tail light. We recommend this for added safety for all riders competing.**

23.5 Riding in the pits must be at walking pace. Any rider who disobeys a warning may be excluded from racing and a \$50.00 fine may be imposed.

23.6 Smoking and Alcohol prohibited in pit areas

23.7 With the exception of Guide dogs, **no dogs are permitted** on the grounds at any time. This is private property and baiting has been done on the property.

23.8 Closed shoes must be worn in the pit at all times.

23.9 Fuel testing may be carried out at any time during any round of the series.

23.10 Presentation will be held Sunday after racing.

23.11 NO CANTEEN AVAILABLE

24. No Hassle Policy: Any rider, entrant or person associated with a rider or entrant shall conduct themselves in an orderly manner in any dealings whatsoever, with any official of the meeting. A rider shall be responsible for his/her own conduct and that of any person with whom he/she is associated who abuses or threatens in any manner, either verbally or physically, any official. Penalties, which may be imposed by the stewards for breach, include reprimand or warning. Minimum \$50.00 fine or exclusion from the meeting.

24.1. Abandonment: In the event of the meeting being abandoned due to circumstances beyond the control of the promoters before racing Commences, entry fees will be returned, less a fee per entry to cover administration costs. Once the competition has commenced only the stewards of the meeting have the authority to abandon the meeting and their decision shall be final. In such cases the stewards will rule on the results according to the circumstances.

24.6. Bicycles: Bicycles are not permitted in the pits or on the racing circuit during racing.

24.1. Abandonment: In the event of the meeting being abandoned due to circumstances beyond the control of the promoters before racing commences, entry fees will be returned, less a fee per entry to cover administration costs. Once the competition has commenced only the stewards of the meeting have the authority to abandon the meeting and their decision shall be final. In such cases the stewards will rule on the results according to the circumstances.

24.6. Bicycles: Bicycles are not permitted in the pits or on the racing circuit during racing.

24.7. Motorcycles: Are to be kept in the pit area at all times when not being used for competition. Unless permission to remove the motorcycle has been granted by the stewards of the meeting. Any motorcycle removed from the pit area without permission of the stewards, will be deemed to have withdrawn from the competition.

24.8. Reservations: The Stewards of the meeting reserve the right to alter, postpone or cancel all or part of the events program.

24.9. Unauthorised: Persons are prohibited from entering the track infield area. Such unauthorised persons will be removed from prohibited areas.

24.11. Property Details/Directions:

- **No recovery of bikes during the course of the event unless deemed safe and approved by chief race official's. Any recovery without permission will be referred to the race steward.**
- **No dogs, possible baiting on property.**
- Take home all rubbish, (some camping areas will have drums only for cans and bottles),
- No fires on fire ban days.
- Bring your own fire wood,
- ****All efforts are made to keep this property safe and enjoyable for all, however all riders and campers are there at their own risk****

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

2. In this declaration:
- a) "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
 - b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
 - c) "MA" means Motorcycling Australia Limited;
 - d) "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
 - e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
 - f) "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

3. I ACKNOWLEDGE that:
- a) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
 - i) that I may be injured, physically or mentally, and may be killed;
 - ii) that my machinery or equipment may be damaged, lost or destroyed;
 - iii) that competitors may ride dangerously or with a lack of skill;
 - iv) that track or event conditions may be hazardous and may vary without warning or predictability;
 - v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
 - vi) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
 - vii) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
 - viii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
 - b) the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
 - c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
 - d) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

4. WARNING UNDER THE Australian Consumer and Fair Trading Act 2012 (Vic)

Under the provisions of the Australian Consumer and Fair Trading Act 2012 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:
- rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 22N of the Australian Consumer and Fair Trading Act 2012 (Vic) the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 (Vic) if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in Regulation 5 of the Australian Consumer Law and Fair Trading Regulations 2012 (Vic).

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees.

INDEMNITY AND RELEASE GIVEN TO ORGANISERS

5. IN CONSIDERATION of the acceptance of me as a participant in the Meeting:

- a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnitees and each of them in the following manner:
 - i) that I participate in the meeting at my sole risk and responsibility;
 - ii) that I accept the Venue as it stands with all or any defects hidden or exposed;
 - iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

b) I AGREE TO RELEASE to the full extent permitted by law the Indemnitees and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arises as a result of any act, matter or thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.

6. The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.

7. A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

MEDICAL

8. I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

9. I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

PRIVACY

10. MA, my SCB use and disclose personal information for the purposes of conducting and administering Motorcycling Activities and other related activities, including for identifying participants, recording results and providing member services or promotional material. MA collects, uses and discloses personal information in accordance with its privacy policy. MA may share your information with third parties as required by law, and including but not limited to disclosing your personal information for the purpose of administering Motorcycling Activities. The MA privacy policy contains information about how to access and correct personal information held by MA or how to make a complaint. Applications or services may be rejected if requested information is not provided. In certain circumstances, your information may be disclosed overseas, for example, to FIM. Contact information and a copy of MA's privacy policy is available on our website at www.ma.org.au/.

PERSONAL HEALTH INFORMATION

11. I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

- a) I ACKNOWLEDGE that:
 - i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
 - ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organisers and facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and
 - iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).

b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:

- i) may collect and store any of my Information, including obtain my Information from third parties including my Carers;
- ii) may use any information collected in accordance with this clause for any purpose consistent with creating safer

competition in motorcycle sport and events held by or in conjunction with MA, my SCB, or with an MA or SCB permit; may disclose my Information to third parties provided such disclosure is reasonably intended to be used for the purpose of improving safety at events held by or in conjunction with MA, or with an MA permit provided any such information is held by MA or my SCB in accordance with the MA Privacy Policy.

c) I irrevocably authorise MA and my SCB and hereby appoint MA and my SCB as my lawful attorneys to collect from my Carers, and I hereby direct my Carers to provide to MA or my SCB upon request being made by MA or my SCB, any of my Information including but not limited to any information concerning any incident or event causing or contributing to or resulting from any injury, illness or death to me, the details of any diagnosis and prognosis provided to me by my Carers (or any party with the knowledge of any of my Carers), and any other matter to the knowledge of my Carers that might reasonably be considered to be requested by MA or my SCB for the purpose of improving safety at MA and SCB events.

POLICIES AND REGULATIONS

12. I acknowledge, understand and agree that it is a condition of my participation in the Event that I agree to be bound by, and subject to, the rules, regulations and jurisdiction of MA as amended from time to time.
